Membership Dues

AFRA offers corporate membership with dues based on the number of employees in the entire company including all affected divisions, subsidiaries, and associated joint ventures.

Each division, subsidiary, and joint venture included in membership will be an independent voting member.

AFRA members are subject to membership and voting requirements specified in the AFRA Bylaws. Submitting this application constitutes that the signer has read and understands the AFRA Bylaws and agrees to the terms, goals and procedures described therein.

Initiation Fees

Wholly-owned and/or independent divisions, subsidiaries and/or joint ventures are required to pay a separate initiation fee.

If the parent company of the division, subsidiary and/or joint venture is already an AFRA member in good standing, each division, subsidiary and/or joint venture will receive a 50% discount on initiation fees.

If the parent company and its divisions, subsidiaries and/or joint ventures are joining AFRA simultaneously, each entity receives a 50% discount on its initiation fee.

If the parent company is an AFRA member in good standing and chooses not to extend AFRA membership to its divisions, subsidiaries and/or joint ventures, those entities that join AFRA separately may receive a 50% discount on initiation fees.

AFRA Accreditation

All AFRA Accredited companies are exempt from initiation fees and receive a 50% discount on membership dues for the first year.
